

Copyright Policy - Adison Park

1. Introduction

Adison Park ("we," "our," "us") respects the intellectual property rights of others and expects our users to do the same. This Copyright Policy outlines our procedures for addressing copyright infringement claims related to content on our website, adisonpark.in.

2. Intellectual Property Rights

All content on our website, including but not limited to text, images, graphics, logos, videos, and software, is the property of Adison Park or our content suppliers and is protected by international copyright laws. Unauthorized use of any material from our website is prohibited.

3. Copyright Infringement Claims

If you believe that your copyrighted work has been copied in a way that constitutes copyright infringement, please provide our designated Copyright Agent with a written notice that includes the following information:

- **Identification of the copyrighted work:** Provide a description of the copyrighted work that you claim has been infringed.
- **Identification of the infringing material:** Provide a description of where the allegedly infringing material is located on our website.
- **Contact information:** Provide your name, address, phone number, and email address.
- **Statement of good faith belief:** Include a statement that you have a good faith belief that the material is not authorized by the copyright owner, its agent, or the law.
- **Statement of accuracy:** Include a statement that the information in your notice is accurate and that you are authorized to act on behalf of the copyright owner.
- **Signature:** Provide your physical or electronic signature.

4. Response to Copyright Infringement Claims

Upon receiving a valid copyright infringement notice, we will promptly investigate and respond to the claim. If we determine that the material infringes on the copyright of a third party, we will remove or disable access to the material. We will also notify the user who posted the material about the claim and provide them with an opportunity to respond.

5. Counter-Notification

If you believe that your material was removed or disabled as a result of a mistake or misidentification, you may submit a counter-notification to our Copyright Agent. Your counter-notification should include:

- **Identification of the material:** Identify the material that has been removed or to which access has been disabled and its location before removal.
- **Statement of good faith belief:** Include a statement that you have a good faith belief that the material was removed or disabled as a result of a mistake or misidentification.
- **Contact information:** Provide your name, address, phone number, and email address.
- **Statement of consent to jurisdiction:** Include a statement that you consent to the jurisdiction of the federal court located in [Your Jurisdiction] and that you will accept service of process from the person who provided the original infringement notice or their agent.
- **Signature:** Provide your physical or electronic signature.
